FIRM SECURES FORT MONMOUTH GOLF COURSE AND GIBBS HALL FOR CLIENT

Gibbs Hall has since received a much-needed facelift with meticulous attention to the detail of the original structure. A patio was added which overlooks the golf course and provides a striking setting for corporate retreats, wedding receptions, and other events. It is anticipated that the extensive renovations to Gibbs Hall will be completed in time for a projected opening in Summer 2023.





Sun Eagles Golf Course was originally designed by A.W. Tillinghast, the noted golf course architect from the early 20th century. Tillinghast designed such notable golf courses as Winged Foot, Ridgewood, Bethpage Black and others that have hosted national and international championships. Our client's goal was to preserve this gem and return the golf course to its former glory. The golf course has remained open throughout the construction. This season it will feature new green complexes and new and renovated tee box grounds and locker room.

WHAT CASES MIGHT BE SUITED FOR MEDIATION? An Informative Article by Douglas J. Widman, Esq.

In mediation, the parties select a neutral third party to serve as their mediator. The role of the mediator is to assist and guide the parties, who are actively involved in the process, to a mutually acceptable conclusion of their dispute.

Mediation has been successful in a broad range of cases that exhibit characteristics such as:

- The parties have an ongoing business or personal relationship or have had a significant past relationship;
 - Communication problems exist between the parties;
 - The principal barriers to settlement are personal or emotional;
- Parties want to tailor a solution to meet specific needs or interests;
- Cases involve complex technical or scientific data requiring particular expertise;
- The parties wish to retain control over the outcome of the case;
- Or the parties seek a more private forum for the resolution of their dispute.

While all case types could potentially benefit from mediation, commercial, construction, employment, environmental and *Law Against Discrimination* (LAD) cases, as well as certain General Equity and Probate cases, are particularly suited to mediation because they tend to exhibit some of the characteristics described above.
