#### ATTORNEY DOUG WIDMAN MEDIATES EMPLOYMENT WHISTLEBLOWER MATTER TO RESOLUTION

Via the Superior Court of New Jersey Ocean County, the Plaintiff alleged unlawful termination in violation of the Conscientious Employee Protection Act (CEPA) and unpaid overtime in violation of the New Jersey Wage and Hour Law.

Per documentation, the Plaintiff was a full-time employee of Defendant employer for many years. During this time, Plaintiff worked multiple overtime hours, however, 'rolled back clock entries' as Plaintiff was aware Defendant preferred not pay overtime. During a work shift, as documented, Plaintiff became aware of a potentially hazardous condition, thus promptly advising a co-worker and management. After multiple weeks and multiple reminders to management, the hazardous condition was allegedly never addressed.

Plaintiff was first suspended without pay then terminated for allegedly stealing time.

Superior Court assigned the matter to head of Davison Eastman Muñoz Paone, P.A.'s arbitration and mediation group, partner Douglas J. Widman, Esq., and Doug mediated the entire workplace matter to final resolution.

Defendant, the employer, agreed to pay employee, the Plaintiff, within 30 days. In turn, Plaintiff, the employee, agreed to pay Defending employer for liquated damages and maintain strict confidentiality of entire circumstance indefinitely.
